

3. The Anti-Ragging Squad shall be responsible

- i) To maintain vigil, over-sight and patrolling functions and shall remain mobile alert and active at all times within the premises of the Institution
- ii) To make surprise raids on places vulnerable to incidents and having the potential for ragging and shall be empowered to inspect such places
- iii) To conduct an on-the-spot enquiry into any incident of ragging referred to it by Director of the college or any member of the faculty or any member of the staff or any student or any parent or guardian or any employee of a service provider or by any other person as the case may be.
- iv) To conduct the enquiry, subject to observing a fair and transparent procedure and the principles of natural justice and after giving adequate opportunity to the student or students accused of ragging and other witnesses and the facts placed before it, documents and views concerning the incidents of ragging and also consideration of such other relevant information as may be required
- v) To submit the report after observing the instructions contained in (iii) and (iv) above to the Anti-Ragging Committee, which in turn, shall forward the same to Managing Director IMS, for her perusal and necessary orders, if any.

The Committee shall ensure to comply with all the provisions of **All India Council for Technical Education (Prevention and Prohibition of Ragging) Regulations 2009** and publicize anti-ragging measures being taken by the Institute by displaying these on notices at entrance gate and on Notice Boards of the Institute and take all necessary possible steps for prevention of ragging in the premises of the institute
